Thank you for your patience during this construction, any questions please contact Steve at the office.

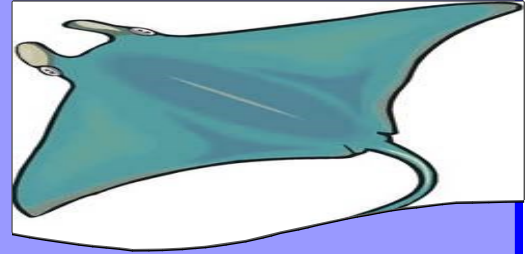
Are you already dreaming of Spring??
